**QUALIFICATIONS**

1. Applicant must be a first generation student, member of an underrepresented ethnic or racial minority, and/or show financial need. Student must be a U.S. citizen or Permanent Resident.
2. Applicant must be a resident of the State of Colorado as defined by the statute for in-state classification.
3. Applicant must be a graduating high school senior during the spring of 2006.
4. Applicant must enroll at a 2 or 4-year Colorado college or university in the fall of 2006 and take a minimum of 6 credit hours.
5. Applicant must have a minimum cumulative high school grade point average of 2.80 on a scale of 4.00.
6. Applicant will be selected by, but not limited to, the following criteria: leadership and community service -particularly within minority communities, past academic performance, personal and professional accomplishments, personal attributes, special abilities, academic goals, and financial need.

**INSTRUCTIONS**

1. All three parts of the application must be typed or written legibly and all questions must be answered. If a question does not apply, please respond with "Not Applicable" or "N/A".
2. Provide an official high school transcript.
3. Provide a copy of your 2006-2007 Student Aid Report (SAR) (visit [www.FAFSA.ed.gov](http://www.FAFSA.ed.gov) to obtain a copy) as described in Part II.

This award for a maximum amount of \$1,000.00 is non-renewable and contingent upon the availability of funds. Awards are competitive and will be based on the scholarship application information, the personal essay, and the individual or parental financial information. In case of ties, the postmarked date may be considered. Disbursement of funds is contingent upon enrollment at a Colorado college or university as stated in Qualifications.
